Entry form changes, additions, corrections and cancellations **MUST** be received **by email** (preferred) or **in legible writing** prior to the October 14th closing date, or no refund will be issued. No telephone changes accepted. No refunds for entry form errors made by the entrant. All entries will be acknowledged via email.

Entries not on official herding entry forms, or photocopies of entry forms, without the Release Form along with the entry form are not acceptable. No entry shall be accepted which specifies any condition as to its acceptance. Returned checks do not constitute a valid entry fee. An alternate list will be kept for all entries over the entry limits.

Entry fees will not be refunded if a dog is absent, disqualified, excused by a judge, or barred from the competition by actions of the Trial Committee. Entry fees will not be refunded if the trial cannot open or be completed by reason of riot, civil disturbance, fire or Act of God, public emergency, act of public enemy, strike or any other cause beyond the control of the club.

Refunds of entries pulled after closing date will be made as long as an alternate run entry; if no alternate runs, no refund will be given.

#### **SITE INFORMATION:**

This event is being held at a working farm. Please close all latches and gates. **Exhibitors MUST clean up after their dogs and themselves!**

Morning hospitality will be provided courtesy of OVPWCC. Lunch and drinks will be available on site at a modest price. If the weather is cold, a hot item will be available.

Dogs MUST be confined in vehicles or crated. Crates/ex-pens need to be placed only in the areas designated by the Trial Committee. Dogs should be leashed when not in the arena. Bring your own shade tents, chairs, water and rain gear. It is often rainy and cool this weekend – dress appropriately and be prepared for muddy paws.

**Herding Instinct Test:** All instinct tests will be in an area no smaller than 50 x 50 feet nor larger than 100 x 100 feet area. Instinct tests are open to dogs older than 9 months and of breeds accepted into the AKC herding program. A complete listing of breeds eligible to participate in instinct tests can be found on the AKC website at [www.akc.org/events/herding/eligiblebreeds/](http://www.akc.org/events/herding/eligiblebreeds/). Instinct tests are judged on a pass/fail basis and no formal herding training is required. A dog must qualify twice (be entered in both Test #1 and Test #2) to complete the requirements for a Herding Instinct Certificate.

If entries exceed limits, an alternate list will be maintained by Trial Secretary. Alternatives will be notified. All alternates must report to the Trial Secretary before the start of the first instinct class. If you do not, your spot may be given to the next alternate on the list.

Bitches in season will run last in the classes.

**From the north on I-65:** Take Exit 20B on **right** toward Owensboro/Bowling Green and merge onto I-165 North

4.8 miles, take Exit 5 (US-68) toward Russellville/Bowling Green, turn left onto US-68

3.3 miles, turn Right onto KY-1083/Browning Rd

1.1 miles, turn Right onto Fuqua Rd, follow gravel drive to High Reaches Farm on Right

**From the south on I-65:** Take Exit 20A-B toward Owensboro/Scottsville

Take Exit 20B toward Owensboro/Bowling Green, then follow From the North directions above

## **PROTOCOL FOR ATTENDANCE AT HIGH REACHES FARM EVENTS**

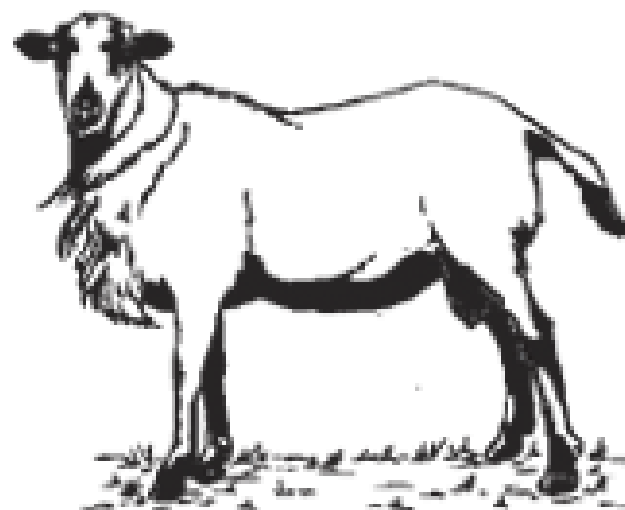
1. STAY HOME IF YOU DO NOT FEEL WELL. Check your temperature if you have doubts.
2. Everyone must have a face covering on their person while at High Reaches Farm, and when worn it must cover BOTH nose and mouth.
3. Face coverings may be pulled down in outdoor areas as long as you are at least 10 feet from other persons.
3. Bring hand sanitizer. We will have additional sanitizer and hand washing stations.
4. Social Distancing: Maintain 10 feet or more from others while at High Reaches Farm.
5. Park spaced such that safe distance can be maintained around vehicles.
6. Maintaining good hygiene: Touch points will be sanitized after each run.
7. Please use hand sanitizer, or wash your hands, just prior to and after your run.

### **ALL ENTRANTS!!!**

Please review the current High Reaches Farm guidelines which can be found above. **While these guidelines are currently suspended, you are required to read and be prepared to comply should conditions change. Any updates will be sent to exhibitors via email.** If AKC and/or CDC guidelines require masks requirement as well as the physical distancing (as detailed herein) at the time of the event, the trial secretary will notify each entrant and signs will be posted on site. While we do not anticipate a change that would affect the event, CKHGC and High Reaches Farm will abide by any state and local mandates in effect at the time of the trial. Exhibitors not abiding by these guidelines will be asked to leave the trial (no refunds will be issued).
