DIRECTIONS TO SITE:

From the north on I-65: Take Exit 20B on **left** toward Owensboro/Bowling Green and merge onto I-165 North 4.8 miles, take Exit 5 (US-68) toward Russellville/Bowling Green, turn left onto US-68 3.3 miles, turn Right onto KY-1083/Browning Rd 1.1 miles, turn Right onto Fuqua Rd, follow gravel drive to High Reaches Farm on Right

From the south on I-65: Take Exit 20A-B toward Owensboro/Scottsville Take Exit 20B toward Owensboro/Bowling Green, then follow From the North directions above

PROTOCOL FOR ATTENDANCE AT HIGH REACHES FARM EVENTS

1. STAY HOME IF YOU DO NOT FEEL WELL. Check your temperature if you have doubts.
2. Everyone must have a face covering on their person while at High Reaches Farm, and when worn it must cover BOTH nose and mouth.
3. Face coverings may be pulled down in outdoor areas as long as you are at least 10 feet from other persons.
3. Bring hand sanitizer. We will have additional sanitizer and hand washing stations.
4. Social Distancing: Maintain 10 feet or more from others while at High Reaches Farm.
5. Park spaced such that safe distance can be maintained around vehicles.
6. Maintaining good hygiene: Touch points will be sanitized after each run.
7. Please use hand sanitizer, or wash your hands, just prior to and after your run.

Please review the current High Reaches Farm guidelines which can be found above. Any updates will be sent to exhibitors via email.

Please make sure you are comfortable with the mask requirement as well as the physical distancing requirement. OVPWCC and High Reaches Farm will abide by any state and local mandates in effect at the time of the trial.
