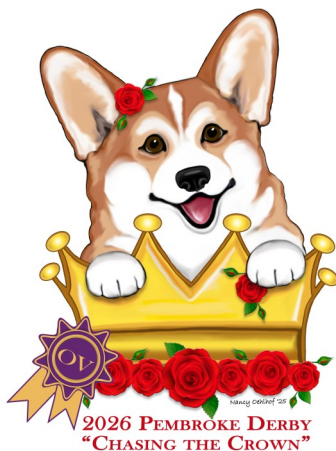

**Points for Reserve Available.** The dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five-point major, in the region in which the event is held. No major for Reserve Winners shall be given based upon an award of Best of Winners.

**Awards of Merit.** At the judge's discretion, an Award of Merit may be awarded to up to 10% of the entry in Best of Breed. An Award of Merit will not be given to the Best of Breed, Best of Opposite Sex, Winners Dog, Winners Bitch, Select Dog or Select Bitch.

**Best Puppy** involves the winners of the 6-9 and 9-12 month puppy classes (BBE Puppy class will not be included). Even if one puppy has beaten another by virtue of receiving Winners or Reserve from the classes, all four puppies return to the ring for the judging of Best Puppy. This is a separate, non-regular class most frequently judged by the Best of Breed judge. What happened in the regular classes has no bearing on the Best Puppy award.

**Best Bred-by-Exhibitor Puppy (6-12 Months)** involves the winners of the BBE Puppy classes.

**Best Bred-by-Exhibitor (12+ Months)** involves the winners of the BBE Adult classes.

**Best Veteran** involves the winners of the four Veterans Classes.

Winners of the Veteran Classes may compete in Best of Breed Competition if otherwise undefeated the day of the show. The AKC allows spayed bitches and castrated dogs to be shown in the Veterans Class at Independent Specialty Shows, and are eligible for competition in Best of Breed. *Chapter 11, Section 8 of the Dog Show Rules.*

## Sweepstakes & Veteran Sweepstakes

### Division of Prize Money

The club will retain 35% to cover expenses.

The remainder of the entry fee (65%) will be awarded as follows:

First in each class .....	40%

### PUPPY SWEEPSTAKES

Sweepstakes are open to dogs and bitches 6 months and under 18 months. Each entry must also be entered in the Regular Classes at this show. Champions of Record are NOT eligible to compete. Indicate Sweepstakes on the regular entry form in the space for additional classes (state age).

## 4-6 Month Beginner Puppy Competition

One combined class, not divided by sex, will be offered for Pembroke Welsh Corgis that are at least four months and under six months of age on the day of the competition. All of the puppies are exhibited in the same class and the only placements are Best of Breed (BOB) and Best of Opposite Sex to Best of Breed (BOS). Entry and eligibility requirements:

- AKC registration number or an AKC litter number will be required for entries of an AKC recognized breed as listed in Chapter 3, Section 1 of the Rules Applying to Dog Shows. A foreign born dog may enter this class if they are registered in the country of origin.
- All entrants are to be vaccinated (including rabies) in accordance with their veterinarian's protocol.
- Professional handlers, members of their household and current assistants to professional handlers may personally exhibit a dog they own as "Exhibition Only" in the Four-to-Six Month (Beginner Puppy) Competition. "Exhibition Only" entries are not eligible to earn awards in this competition.
- Dogs that are owned or co-owned by a professional handler, members of their household, or current assistants to professional handlers may compete for awards in this competition but must be handled by a non-professional handler. Professional handlers are defined as any person who belongs or has belonged to a professional handlers' organization, distributed rate cards, or otherwise advertised or represented themselves as handling dogs for pay within the last five years. Dogs may not be exhibited by current assistants and household members of a professional handler.
- Exhibition Only entries may not be changed to be eligible to compete for awards after the close of entries.
- Minors (under 18) with amateur status who reside with professional handlers and current assistants to professional handlers that are eligible to compete in Junior Showmanship (meet age and amateur status requirements) may personally exhibit dogs in the Four-to-Six Month (Beginner Puppy) Competition.

### Novice Class

For boys and girls at least 9 and under 18 years of age on the day of the show who at the time entries close, have not won three first places with competition present in a Novice Class. A first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open. Junior Handlers who win a third Novice Class with competition, if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open, after the closing of entries for a show are required to transfer their entry from the Novice Class to the Open Class.

### Open Class

This class shall be for boys and girls who are at least 9 years old and under 18 years old on the day of the show, and who have won three first place awards in a Novice Class or if a win in Novice leads to a Best Junior with competition present it will count as one win towards moving to Open in a licensed or member show.

### Master Class

This class will be for boys and girls who are at least 9 years old and under 18 years on the day of the show, and who have won 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.

(Rules Applying to Dog Shows, Chapter 11, Section 6). Each Owner/ Agent listed on the entry form and/or individual responsible for the dog at the show is bound by the Certification and Agreement on the front and back of the entry form regardless of who may have completed and submitted the form. No entry fee will be refunded in event of such errors, or cancellation of entries after the published closing date. No refund for duplicate entries. No entry will be accepted which specifies any conditions as to its acceptance.

Effective January 1, 2026: An AKC Recording Fee of \$.50 (first entry only), an AKC Event Service Fee of \$4.00 for the first entry of a dog and \$4.50 service fee for each additional entry of the same dog in regular and non-regular recordable single entry classes will be required for each dog entered at all Licensed or Member Club events. An AKC Recording Fee of \$.50 will be required for each entry in any Licensed or Member Club Rally Trial. All Recording and Event Service Fees are collected by the event-giving club and paid to the American Kennel Club. There is no Recording Fee or Event Service Fee for Junior Showmanship, Sweepstakes, Futurities, Brace/Team, Multi-Dog Classes or Special Attractions. (Rules Applying to Dog Shows, Chapter 11, Section 2 and AKC Rally Regulations, Chapter 1, Section 4)

Entry fees will not be refunded in the event that a dog is absent, disqualified, or excused by the Judge or Veterinarian, or barred from competition by action of the Show Committee. If because of riots, civil disturbances, or other acts beyond the control of the show giving club, it is impossible to open or complete the show, no refunds will be made.

No entry may be changed or canceled unless notice of the change or cancellation is received in writing by the Show Secretary prior to the closing date and hour for entries, except that a correction may be made in the sex of a dog, or a dog may be transferred from one division of the Puppy Class to another or between the Puppy and Twelve-to-Eighteen Month Class at a show prior to the judging. A dog determined to be ineligible, by its owner/agent, for the class in which it has been entered may be transferred to an eligible open class at a show prior to the judging of any regular conformation class within the sex of that breed or variety, and that dogs which according to their owners' records have completed the requirements for a championship after the closing of entries for a show but whose Championships are unconfirmed, may be transferred from one of the regular classes to the Best of Breed or Variety competition, provided this transfer is made by the Superintendent or Show Secretary at least one half-hour prior to the scheduled start of any regular conformation judging at the show. No dog may otherwise be transferred to another class. Owners are responsible for errors in the entry forms, regardless of who may make such errors.

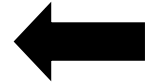
## AGREEMENT
